## Addendum No. 2

This Addendum No. 2 shall be part of the Request for Qualifications for the Puerto Rico Electric Power Hydroelectric Power Plants Revitalization Project (the “RFQ”) issued by the Puerto Rico Public-Private Partnerships Authority on April 16, 2019. Capitalized terms not defined herein shall have the meaning set forth in the RFQ.

The purpose of this Addendum No. 2 is to modify certain terms set forth in the RFQ. Other than as specified herein, there are no other changes to the RFQ and the remainder of the RFQ should be construed in accordance with its terms, subject to publication of any additional addenda.

### 1.6 Process and Schedule

The following paragraphs of Section 1.6 of the RFQ are hereby amended as follows, with inserted language indicated in blue, and deleted language indicated in red strikethrough text:

*Below is a summary schedule of the major activities associated with the RFQ Process. The dates and activities are subject to change and may be revised through the issuance of addenda to this RFQ.*

<b>April 16, 2019</b>	<i>Date of issuance and first publication of public notice of RFQ by the Authority.</i>
<b>April 26, 2019</b>	<i>Deadline for submission of Requests for Clarification with respect to this RFQ by prospective Respondents (“RFCs”).</i>
<b>May 10, 2019</b>	<i>Deadline for the Authority to release responses to RFCs.</i>
<del>June 3</del> <b>July 22, 2019</b>	<i>Deadline for submission of SOQs (no later than 5:00 pm AST).</i>
<del>June 17</del> <b>August 5, 2019</b>	<i>Estimated date for notification of Qualified Respondents.</i>

**All SOQs must be submitted by no later than ~~June 3~~ July 22, 2019 at 5:00 pm AST (the “Submission Deadline”) in the manner set forth in Section 4 of this RFQ.**
