ECONOMIC AND DISASTER RECOVERY PLAN PUBLIC COMMENTS INSTRUCTIONS

The United States Congress (Congress) enacted the Bipartisan Budget Act of 2018, Pub. L. 115-123 (Act), which required in Section 21210, that the Government of Puerto Rico develops an Economic and Disaster Recovery Plan (Recovery Plan) that must be submitted on August 8, 2018. Therefore, the Central Recovery and Reconstruction Office of Puerto Rico (COR3) has been developing the Recovery Plan in coordination with the Federal Emergency Management Administration (FEMA), the Homeland Security Operational Analysis Center (HSOAC), and key stakeholders across Puerto Rico.

As a part of the Act's requirements, the COR3 publishes the draft of the Recovery Plan for public comments that can be provided either in English or Spanish language. The COR3 may also, but will not be obliged to incorporate, accept, respond or inquire with follow-up regarding the comments received. The comments to the draft Recovery Plan must comply with the following requirements:

- (1) Comments shall be submitted on or before July 18, 2018 at 11:59 p.m. (AST).
- (2) Comments can be submitted via an Electronic PDF document to the following e-mail address: **info@cor3.pr.gov**.
- (3) Responses are limited to five pages in the 8" x 11.5" paper size using 12-point font and 1-inch margins.
- (4) In the document where comments will be submitted to the COR3 the following must be included:
 - a. Name
 - b. Contact Information:
 - i. Email Address;
 - ii. Mailing Address; and
 - iii. Phone Number.
 - c. Which entity(ies) do you represent as an individual or business a:
 - i. Community;
 - ii. Municipality (please state which one);
 - iii. State Agency;
 - iv. Federal Agency;
 - v. Business (please state the name), or
 - vi. Private Non-Profits.

- ✓ Base your justification on sound reasoning, scientific evidence, and/or how you will be impacted
- ✓ Address trade-offs and opposing views in your comments
