Dear Members of the Partnership Committee,

In accordance with Article 8(b) of Act No. 29-2009, as amended, known as the Public Private Partnerships Act (“Act 29”) and Section 3.4 of *Regulation for the Procurement, Evaluation, Selection, Negotiation and Award of Partnership Contracts and Sale Contracts for The Transformation of the Electric System Under Act No. 120-2018, as Amended* (the “Regulation”), the Puerto Rico Public Private Partnerships Authority (the “Authority”) hereby submits for your consideration a request to approve the draft version of Addendum No. 6 to be provided to the Proponents in the Request for Proposals for Puerto Rico Electric Power Transmission and Distribution System RFP 2019-2 (“RFP”) approved by the Partnership Committee (the “PC”) on February 1, 2019 (“Addendum No. 6”). Addendum No. 6 includes the definitive proposal submissions instructions to Proponents and revisions to the Evaluation Criteria, among others.
