In accordance with Article 8(b) of Act No. 29-2009, as amended, known as the Public Private Partnerships Act (“Act 29”) and Section 3.4 of *Regulation for the Procurement, Evaluation, Selection, Negotiation and Award of Partnership Contracts and Sale Contracts for The Transformation of the Electric System Under Act No. 120-2018, as Amended* (the “Regulation”), the Puerto Rico Public Private Partnerships Authority (the “Authority”) hereby submits for your consideration a request to approve the draft versions of the Operation and Maintenance Agreement (“O&M Agreement”) and Financing Term Sheet to be provided to the Proponents in the Request for Proposals for Puerto Rico Electric Power Transmission and Distribution System RFP 2019-2 (“RFP”) approved by the Partnership Committee (the “PC”) on February 1, 2019.

For your benefit, the Authority includes the most recent version of the O&M Agreement and a blackline version showing the revisions made since the O&M Agreement was first circulated last Wednesday May 15, 2019. Unanimous written consent from all Members of the PC is required to approve this Addendum No. 2.
