AMENDMENT TO THE DESIGNATION OF THE PARTNERSHIP COMMITTEE FOR THE SAN JUAN CRUISE PORTS FACILITIES PUBLIC-PRIVATE PARTNERSHIP PROJECT, PURSUANT TO ACT NO. 29-2009, AS AMENDED

WHEREAS, pursuant to the provisions set forth in Act 29-2009 ("Act 29"), as amended, the Puerto Rico Public-Private Partnerships Authority ("Authority") is the government entity in charge of implementing the public policy that seeks to promote the establishment of public-private partnerships;

WHEREAS, pursuant to Resolution 2018-44 of June 14, 2018, the Authority's Board of Directors designated the composition of the Partnership Committee for the San Juan Cruise Facilities public private partnership project ("Cruise P3 Project") as follows:

- Executive Director of the Puerto Rico Fiscal Agency and Financial Advisory Authority, or his/her delegate;
- Executive Director of the Ports Authority, the Partnering Government Entity, or his/her delegate;
- Héctor Del Río, Esq., as a Member of the Board of Directors of the Partnering Government Entity, or his/her delegate;
- Sr. Luis Umpierre, chosen by the Authority for his knowledge and experience in the kind of project covered by the public-private partnership under consideration; and
- Sra. Noelia García, chosen by the Authority for his knowledge and experience in the kind of project covered by the public-private partnership under consideration;

WHEREAS, with the purpose to continue with the Cruise P3 Project, the Authority requests authorization to modify the composition of the Partnership Committee;

WHEREAS, the Authority requests that the Board of Directors replaces the designation of Héctor del Río, Esq., as member of the Cruise P3 Project Partnership Committee, for Secretary Manuel Laboy, and amend the Resolution 2018-44 to read as follows:

- Executive Director of the Puerto Rico Fiscal Agency and Financial Advisory Authority, or his/her delegate;
- Executive Director of the Ports Authority, the Partnering Government Entity, or his/her delegate;
- Secretary Manuel Laboy, as a Member of the Board of Directors of the Partnering Government Entity, or his/her delegate;
- Sr. Luis Umpierre, chosen by the Authority for his knowledge and experience in the kind of project covered by the public-private partnership under consideration; and
- Sra. Noelia García, chosen by the Authority for his knowledge and experience in the kind of project covered by the public-private partnership under consideration.

NOW THEREFORE, BE IT RESOLVED, by the Board of Directors of the Puerto Rico Public-Private Partnerships Authority, to appoint the Partnership Committee Members specified above as the Cruise P3 Project committee members, pursuant to the provisions of Act 29 and to authorize the Executive Director of the Authority to execute all necessary documents in furtherance thereof.

This Resolution shall be effective immediately upon its approval.
