



Summary Description of Confidentiality

We respectfully request that the Puerto Rico Public-Private Partnerships Authority (“P3”) maintain the confidentiality of the information that has been redacted in the bid proposal, data sheet and subsequent correspondence listed below that were submitted by Genera PR LLC (the “Proponent”) in response to the various requests for information from P3 as of February 18, 2022.

The commercial and financial information redacted in the bid proposal, data sheet and information request responses is confidential under Puerto Rico evidentiary law and the Industrial and Trade Secret Protection Act of Puerto Rico. Further, the Puerto Rico Supreme Court has held that people have an expectation of privacy over their financial and banking information, their transactions, and their businesses. This right has been extended to corporate entities. Disclosure of the information redacted in the bid proposal, data sheet and information request responses would reveal trade, commercial and industrial secrets of the Proponent without providing any benefit for the protection of the public interest.

Although the Proponent understands that certain of this information will eventually be made public should it ultimately be awarded the bid, the disclosure of this information in advance of such award would reveal information that has a present or a potential independent financial value, that provides a business advantage to the Proponent, would reveal trade secrets and the Proponent’s proprietary commercial strategy, provide third parties with a competitive advantage upon discovery, or reduce the Proponent’s strategic advantages in possible future negotiations with third parties, in each case, insofar as such information is not presently common knowledge or readily accessible to the public. Disclosure of this information could also harm the rights of third parties with whom the Proponent has contractual obligations of confidentiality and expose protected sets of customer and business associate information.

The following items are covered by this category of confidential materials:

- Specific information about the business strategy of New Fortress Energy and the Proponent, the disclosure of which would reveal trade secrets of the relevant company.
- Specific information about the way New Fortress Energy or the Proponent does or plans to do business in Puerto Rico and how the Proponent would transform the Puerto Rico energy generation system, if the bid were awarded.



- Responses to request for proposal prompts and supplementary requests for information that convey our business strategy, including, but not limited to: our general strategic approach to future operation and maintenance of the assets; our strategy for approaches with future employees, subcontractors, and other third parties; strategy for discussions and timing of certain hiring or maintenance-related processes or projects; understanding of existing permitting compliance status; and strategy for negotiation of existing contracts.
- Technical information that (i) indicates our strategies on how to interact with subcontractors, employees, stakeholders, and regulators, among other groups; (ii) contains our hiring and management plans; and (iii) provides our proposed rates or price structures.
- Marketing brochures and charts that portray the corporate structures, operational processes, and trade secrets of subcontractors and third parties, with whom we have signed nondisclosure agreements.
- Biographical information about individual employees—whether at NFE or the Proponent, or at one of our potential subcontractors—who are not well known to the public.
- Substantive proposed revisions to the O&M Agreement which reveals our commercial position.
- Signatures or identities of private persons.
- Sensitive security and cybersecurity information or practices.
- Certain financial information about New Fortress Energy and the Proponent, including current and past financing efforts that have not been publicly disclosed.
- Intricate hiring and management plans.
- Information about the projects of subcontractors and their related track records.
